PERAK TURF CLUB APRIL DERBY MEETING 2013
2nd DAY, SUNDAY, 14TH APRIL 2013**

STATE OF TRACK: Races 1 to 5 – Heavy; Race 6 to 7 - Soft

RACE 1 (R512) CLASS 5 – 1600M (lc) – KEEP GOING IV-1982 HANDICAP

Jockey BN Shahrul was fined RM250/- under MRA Rule 152(5)(a) for accepting two rides in this race.

EASY JOB which was down 16kgs in body weight, since its last run, was checked by the Club Veterinary Surgeon prior to the race and was passed fit to start.

BETTER YEAR (BN Shahrul) which stood flat-footed and lost considerable ground, will be required to pass a test (1 starting stall) before being declared to race again.

PLENTY IN HAND (App WT Chung) was slow into stride and thereafter showed no early pace, despite being urged along.

On jumping, LOVE ME (Alan Ng) was crowded for room between FROM ZERO (App KM Lai) which jumped awkwardly outwards and EASY JOB (LL Tai) which jumped awkwardly inwards.

FLASH GORDON (App I Amirul) raced wide first turn.

Near the 1000M, PLENTY IN HAND shifted inwards, anticipating the short course and became unbalanced.

BETTER YEAR raced wide home turn.

Near the 300M, DAVID DYNASTY (J Shankar) steadied and switched inwards across the heels of EASY JOB which shifted outwards under pressure. Jockey LL Tai, the rider of EASY JOB was shown the video of the incident and warned to exercise more care when shifting ground in future.

App WT Chung, the rider of PLENTY IN HAND and Jockey HS Gill, the rider of VERY STYLO both reported that their mounts did not handle the going. Post-race veterinary examinations of PLENTY IN HAND, VERY STYLO and DAVID DYNASTY revealed

no obvious abnormality. PLENTY IN HAND which raced poorly, will be required to pass a test (1000M/vet) before being declared to race again.

The Club Veterinary Surgeon reported that BETTER YEAR had returned lame off-fore and will be required to pass a test (1000M/vet) before being declared to race again.

RACE 2 (R513) CLASS 5 – 1600M (lc) – SIAPA RAJAH III-1981 HANDICAP

Trainer N Azman was fined RM100/- under MRA Rule 65(5)(b) for failing to produce the declared colours on JACK.

On jumping, GEORGIE BOY (App KC Tham) and JACK (J Chuah) bumped.

GIFT'S DAWAN (App KK Chin) raced wide home turn.

Post-race veterinary examinations of I AM WHO I AM (TM Wan) revealed that the gelding had bled and will be barred from racing for a period of three (3) months under MRA Rule 92(3)(a)&(b) and JACK revealed no obvious abnormality.

When questioned regarding the improved performance of AKEMUS (Alan Ng) compared to its last start on the 30th March 2013, Class 5 – 1700M in Kuala Lumpur when it finished 11th, beaten 15 lengths, Trainer P Pereira stated that AKEMUS preferred the heavy track today and was working well in its trackwork. He said that AKEMUS had also improved in its barrier manners and with a gear change to blinkers/pacifiers had contributed to the improved performance. His explanation was noted. Trainer P Pereira was reminded of his obligations of the Rules regarding in-and-out running.

RACE 3 (R514) CLASS 4 – 1600M (lc) – MAN OF HONOUR-1970 HANDICAP

COFFEESHOP GOSSIP (App KM Lai) and BIG RED (J De Souza) which stood flat-footed and lost considerable ground, will each be required to pass a test (1 starting stall) before being declared to race again.

LADY DIAMOND (S Sani) which fly-jumped and lost considerable ground, will be required to pass a test (1 starting stall) before being declared to race again.

BLUE HILLS (BN Shahrul) jumped awkwardly inwards and bumped MONEY IS KING (App WT Chung), thereafter BLUE HILLS raced keenly and was difficult to settle in the early and middle stages and thereafter commenced to hang outwards for the entire journey of the race.

MONEY IS KING drifted outwards under pressure in the home straight and finished the race wide.

App KM Lai, the rider of COFFEESHOP GOSSIP reported that his mount was not striding out freely. A post-race veterinary examination of COFFEESHOP GOSSIP revealed no obvious abnormality. COFFEESHOP GOSSIP which raced poorly, will be required to pass a test (1000M/vet) before being declared to race again.

Post-race veterinary examinations of FLYING HORSE (I Azhar) revealed no obvious abnormality and BIG RED had returned broken-winded and as such, will be required to undergo corrective surgery and 1200M/vet before being declared to race again.

RACE 4 (R515) CLASS 4 – 1600M(lc) – SUNGEI WANG II-1971 HANDICAP

Acting on veterinary advice that KINGFIGHTER was lame off-fore, the Stewards ordered its withdrawal at 2.18pm. KINGFIGHTER will be required to pass a test (1000M/vet) before being declared to race again.

IWA ANTILIA (J Shankar) jumped awkwardly.

ANG PAO KERETA (V Sivan) and SAKKIE SAKKIE (H Barnabas) were slowly away.

FREE GIFT (I Azhar) was slow into stride and thereafter showed no early pace, despite being urged along.

Near the 1400M, MIRACLE PRAY (S Sani) which commenced to race keenly, steadied outwards across the heels of IWA ANTILIA and thereafter continued to race keenly and was difficult to settle in the early and middle stages.

Near the 1000M, STAR OF BRAZIL (J De Souza) steadied off the heels of LIUZZI which rolled outwards.

MAJESTIC AMETHYST (M Wepner) and IWA ANTILIA hung outwards in the home straight and finished the race wide.

LIUZZI drifted outwards under pressure in the home straight, finishing the race wide.

A post-race veterinary examination of ANG PAO KERETA revealed that the gelding returned lame both fore and will be required to pass a test (1000M/vet) before being declared to race again.

Post-race veterinary examinations of FREE GIFT and SUCH A GOOD TIME revealed no obvious abnormality.

RACE 5 (R516) MAIDEN – 1200M(sc) – UNCOMPROMISING-1990 HANDICAP

LOVE BABY which was down 21kgs in body weight, since its last run, was checked by the Club Veterinary Surgeon prior to the race and was passed fit to start.

The saddle on HONESTLY SPEAKING (V Sivan) was re-adjusted behind the barriers.

K-POP (App I Amirul) jumped awkwardly and was slowly away.

HONESTLY SPEAKING fly-jumped and was slowly away.

On jumping, HAPPY LUCK (BN Shahrul) was crowded for room between LORD COLLARI (M Yusri) which jumped awkwardly outwards and OWN DISTINCTION (MW Teh) which jumped awkwardly inwards.

HONESTLY SPEAKING was urged along with the whip in the early stages.

K-POP raced wide first turn.

Jockey H Barnabas, the rider of NOCOLLATERALNEEDED reported that his mount did not handle the going.

Post-race veterinary examinations of LOVE BABY, LORD COLLARI and HAPPY LUCK revealed no obvious abnormality. LOVE BABY and HAPPY LUCK which both raced poorly, will each be required to pass a test (1000M/vet) before being declared to race again.

After the running of this race, the going was upgraded to “Soft”.

RACE 6 (R517) CLASS 5 – 1200M(sc) – JUMBO JET-1972 HANDICAP

HORIZON LAD (A Kumar) was examined by the Veterinary Surgeon behind the barriers and was passed fit to race.

GITHAN (M Djulkifli) was slow into stride and thereafter showed no interest for the remainder of the race.

EASTERN GIFT (J Shankar) jumped awkwardly with its head up and was crowded for room between HEARD THE LATEST (J De Souza) and DOCTOR WU (TM Wan) which jumped awkwardly outwards. EASTERN GIFT lost ground in this incident and thereafter was urged along with the whip in the early stages.

HORIZON LAD (A Kumar) was slow into stride.

Near the 1000M, DOCTOR WU made the crossing awkwardly and in doing so, bumped MID EAST CONQUEROR (App KM Lai).

The saddle on EASTERN GIFT slipped back during the race, placing its rider at a disadvantage.

Jockey M Djulkifli, the rider of GITHAN reported that his mount was not striding out freely. A post-race veterinary examination of GITHAN revealed no obvious abnormality. GITHAN which raced poorly, will be required to pass a test (1000M/vet) before being declared to race again.

Post-race veterinary examinations of EASTERN GIFT and MID EAST CONQUEROR (App KM Lai) revealed no obvious abnormality.

RACE 7 (R518) CLASS 5 – 1200M(sc) – VAARON-1980 HANDICAP

EMPEROR QIAN LONG (Lou Ho) which jumped awkwardly and lost considerable ground, will be required to pass a test (1 starting stall) before being declared to race again.

CHINESE STREET (J Shankar) jumped awkwardly outwards and bumped MORDI (J De Souza).

Shortly after the start, MONEY IS QUEEN (App SL Lam) switched inwards across the heels of PALMSTON (C Goon) which rolled outwards. Shortly afterwards, MONEY IS QUEEN shifted inwards abruptly, obliging its rider to stop and straighten.

EMPEROR QIAN LONG raced wide home turn.

Near the 300M, FIRE GENERAL (TM Wan) laid inwards, obliging its rider to stop and straighten.

Jockey MW Teh, the rider of SMILEY FACE reported that his mount was not striding out freely. A post-race veterinary examination of SMILEY FACE revealed that the gelding returned lame near fore and as such, will be required to pass a test (1000M/vet) before being declared to race again.

Jockey J De Souza, the rider of MORDI reported that his mount did not handle the going.

Post-race veterinary examinations of MONEY IS QUEEN, BLESSINGINDISGUISE (H Barnabas) MONEY NOT ENOUGH (App KK Khoo) and BLUE CENTRE (App I Fadzlei) revealed no obvious abnormality.

The Club Veterinary Surgeon reported that MORDI returned with respiratory distress and as such, will be required to pass a test (1000M/vet) before being declared to race again.

After taking initial evidence from App KK Khoo, the rider of MONEY NOT ENOUGH and Trainer/Master Peter Lee, the Stewards will be inquiring into his ride at a date to be fixed.

GENERAL REPORT(s)

**RACE 1 (R506) CLASS 5 – 1600M(1c) – NORVAL LAD-1962 HANDICAP
1ST DAY, 13TH APRIL 2013, SATURDAY, PERAK APRIL DERBY MEETING 2013**

At the conclusion of an inquiry today (14th April 2013), App CK Tan, the rider of ESSENTIALLY COOL in the presence of his Master/Trainer KL Chong pleaded guilty to a charge of careless riding under MRA Rule 44(9)(a)(ii) in that near the 200M, he allowed his mount, ESSENTIALLY COOL to shift inwards when insufficiently clear of MR MAGIC (K Eirwan), thereby causing that gelding to check and lose ground.

When deciding on penalty, the Stewards took into account App CK Tan's guilty plea, riding record and consequential effects of the incident. App CK Tan's licence to ride in races was suspended for a period of four (4) race days. Acting under the provisions of MRA Rule 48(5), the Stewards deferred App CK Tan's suspension to commence on Monday, 22nd April 2013 and to expire on Friday, 3rd May 2013, both dates inclusive. He was advised of his right of appeal (11.57am).

**RACE 1 (R506) CLASS 5 – 1600M(1c) – NORVAL LAD-1962 HANDICAP
1ST DAY, 13TH APRIL 2013, SATURDAY, PERAK APRIL DERBY MEETING 2013**

After reviewing the films, the Stewards will be inquiring into the ride of Jockey M Helmy when he rode SOVIET SNIPER at a date to be fixed.

**RACE 2 (R507) CLASS 4 – 1100M str – INDIAN HEATHER -1950 HANDICAP
1ST DAY, 13TH APRIL 2013, SATURDAY, PERAK APRIL DERBY MEETING 2013**

When questioned regarding the disappointing performance of SAGA KING, Jockey Lou Ho stated that he was instructed to get a good jump, sit where comfortable and make his move at the 600M. He further stated that SAGA KING was having its first start on the straight course on the soft going and he believed that his mount did not handle the going and when he asked for an effort from the 600M, his mount did not respond as expected and was disappointing. His explanation was noted. Trainer KK Loh confirmed the instructions and was disappointed with the gelding's performance. He said that he further examined SAGA KING today and could find no obvious abnormality to explain the poor run. His explanation was noted. A post-race veterinary examination of SAGA KING revealed no obvious abnormality. SAGA KING which raced poorly, will be required to pass a test (1000M/vet) before being declared to race again.

**RACE 3 (R508) CLASS 4 – 1100M str – COLONEL DALY-1951 HANDICAP
1ST DAY, 13TH APRIL 2013, SATURDAY, PERAK APRIL DERBY MEETING 2013**

At the conclusion of an Inquiry today (14th April 2013), evidence was taken from App KM Lai, the rider of BING IS BEST, in the presence of his Master/Trainer KL Chong. It was established that BING IS BEST shifted out over the heels of CHEEK TO CHEEK (HK Cheng) which was hanging inwards and in so doing, GOOD ARTIST (I Azhar) which was following, had to be checked. App KM Lai was given the benefit of the doubt on this occasion, however, he was warned to exercise more care when shifting ground in future.

**RACE 3(R508) CLASS 4 – 1100M str – COLONEL DALY-1951 HANDICAP
1ST DAY, 13TH APRIL 2013, SATURDAY, PERAK APRIL DERBY MEETING 2013**

Near the 550M, CHEEK TO CHEEK (HK Cheng) shifted inwards after being struck with the whip and bumped BING IS BEST (App KM Lai), causing that gelding to be taken inwards on the track. Jockey HK Cheng was shown the video of the incident and warned to exercise more care when shifting ground in future.

**RACE 3 (R508) CLASS 4 – 1100M str – COLONEL DALY-1951 HANDICAP
1ST DAY, 13TH APRIL 2013, SATURDAY, PERAK APRIL DERBY MEETING 2013**

When questioned regarding the improved performance of HERE COMES THUNDER (TM Wan), Trainer KF Wong stated that HERE COMES THUNDER preparation has been the same and that HERE COMES THUNDER had the advantage of the home-based track on the straight course and the going may have contributed to the improved performance. Trainer KF Wong's explanation was noted and he was reminded of his obligations of the Rules regarding in-and-out running.

**RACE 5 (R510) CLASS 5 – 1200M(sc) – FROGGIE-1961 HANDICAP
1ST DAY, 13TH APRIL 2013, SATURDAY, PERAK APRIL DERBY MEETING 2013**

When questioned regarding the disappointing performance of FLAPJACK, Jockey J De Souza stated that he was instructed to get a good jump, sit midfield and make his move near the 600M. He further stated that when he made his move at the 600M, his mount did not respond as expected and believed that the gelding did not handle the going and was disappointing. Trainer Bonny Ng confirmed the instructions and stated that FLAPJACK did not handle the going. He said that he further examined FLAPJACK today and could find no obvious abnormality. His explanation was noted. A post-race veterinary examination of FLAPJACK revealed no obvious abnormality. FLAPJACK was impounded.
