RACE 1 (R536) CLASS 4 – 1200M (lc) – PEAK OF PERFECTION XI-1998 HANDICAP

BIEBER which was down 17kgs, SATISFACTION which was up 22kgs and SUPER SKY HORSE which was up 16kgs in body weight, since their last run, were checked by the Club Veterinary Surgeon and were passed fit to start.

HOME RUN (TO Chang) was examined by the Veterinary Surgeon behind the barriers and was passed fit to start.

MAJOR STEP (L Sofhan) jumped awkwardly and was slowly away.

SAKKIE SAKKIE (H Barnabas) was slow into stride.

Near the 1100M, MAJOR STEP steadied off the heels of HOME RUN which rolled inwards.

Near the 500M, MAJOR STEP steadied when momentarily crowded for room between BIEBER (App R Vikram) and HOME RUN which rolled outwards. Jockey TO Chang was shown the video and warned to exercise more care when shifting ground in future.

TAVAN BOGD (J Shankar) drifted outwards under pressure over the concluding stages of the race.

Jockey TO Chang, the rider of HOME RUN reported that his mount was not striding out freely. A post-race veterinary examination of HOME RUN revealed that the gelding returned lame near fore and will be required to pass a test (1000M/vet) before being declared to race again.

The Club Veterinary Surgeon reported that SUPER SKY HORSE (HS Gill) had bled and will be barred from racing for a period of three (3) months under MRA Rule 92(3)(a)&(b).

Post-race veterinary examinations of BLACK ARROW (S Salee) and MAJOR STEP revealed no obvious abnormality.

When questioned regarding the performance of BLACK ARROW, Jockey S Salee stated that he was instructed to get a good jump, sit $3^{rd}/4^{th}$ position and make a move at the 600M. He said that when he asked for an effort at the 600M, his mount did not respond and was disappointing. His explanation was noted.

RACE 3 (R537) CLASS 4 – 1200M (lc) – VIBRANT VIRGO-1997 HANDICAP

RIE'S PET, a course scratching which had sustained a cut to its right side upper lip, will be required to pass a veterinary examination before being declared to race again.

UNWIND (LL Tai) and BUKIT BINTANG (App R Rueven) jumped awkwardly.

BELWINS (S John) was slowly away.

Shortly after the start, BUKIT BINTANG steadied when momentarily crowded for room between OCTALERT (D Badel) and SACRED DEW (S Salee) which rolled inwards.

Near the 1000M, OCTALERT steadied when crowded for room between DAZZLING KIND (K Eirwan) and SACRED DEW which shifted inwards. Jockey S Salee was shown the video and warned to exercise more care when shifting ground in future.

HANDSOME BACHELOR (TM Wan) raced wide throughout.

BELWINS raced wide first turn, home turn and drifted outwards under pressure at the 400M and drifted inwards under pressure over the concluding stages of the race.

Near the 300M, SACRED DEW drifted outwards under pressure.

Post-race veterinary examinations of UNWIND, BEFLEDGED (C Goon) and HANDSOME BACHELOR revealed no obvious abnormality.

The Club Veterinary Surgeon reported that CHEEK TO CHEEK returned lame near fore and will be required to pass a test (1000M/vet) before being declared to race again.

RACE 5 (R538) CLASS 3 – 1200M (lc) – VALAISAN-1979 HANDICAP

BE AN ANGEL, a course scratching which had sustained an abrasion to its near fore, will be required to pass a veterinary examination before being declared to race again.

BIG LIGHTNING and EARL GREY which were up 16kgs and 17kgs respectively in body weight, since their last run, were checked by the Club Veterinary Surgeon and were passed fit to start.

ANAK PUJUT (C Goon) and JOYFUL (BN Shahrul) bumped on jumping.

WARN YOU MAN (A Kumar) jumped awkwardly.

On jumping, SIR RALLY (WK Yan) was crowded for room between GOOD POWER (I Azhar) and URBAN DANCER (L Sofhan) which jumped awkwardly outwards.

Shortly after the start, CAMOUFLAGE (App KY Yap) steadied off the heels of BIG LIGHTNING (J Shankar) which rolled outwards.

JOYFUL showed no early pace, despite being urged along.

WARN YOU MAN raced keenly in the early and middle stages of the race.

Near the 800M, GOOD POWER was taken outwards by SHAMACAM (J De Souza) which in turn was taken outwards by BIG LIGHTNING which shifted outwards across the heels of WARN YOU MAN. Jockey J Shankar was shown the video and warned to exercise more care when shifting ground in future.

A post-race veterinary examination of ANAK PUJUT revealed no obvious abnormality.

The Club Veterinary Surgeon reported that BIG LIGHTNING had bled and will be barred from racing for a period of three (3) months under MRA Rule 92(3)(a)&(b).

When questioned regarding the performance of ANAK PUJUT, Jockey C Goon stated that he was instructed to ride a forward race, sit where comfortable and make his move from the 400M. He said that ANAK PUJUT was more suited over the 1100M last start as oppose to the 1200M today and when he asked for an effort in the home straight, his mount did not respond as expected and was disappointing.

RACE 7 (R539) CLASS 5 – 1400M (lc) – FAST FLYING-2007 HANDICAP

Shortly after the start, BUKIT FIRE commenced to buck and dislodged Jockey LL Tai. Jockey LL Tai was attended to by the Club Medical Officer and was exempted from weighing in. He was passed fit to resume the remainder of his riding engagements for the day.

Due to BUKIT FIRE's adverse history, the mare will be required to pass 2 tests (2 starting stall at weekly intervals) before being declared to race again.

HUMBLE HARVEST (J De Souza) was slow into stride.

VISTA (M Helmy) jumped awkwardly outwards and bumped PERHAPS (S Sani) causing PERHAPS to lose ground.

DIAMONDINDRUFF (H Barnabas) jumped awkwardly inwards and bumped LEE DANCER (S John) causing LEE DANCER to lose ground.

DOCTOR WU (TM Wan) raced keenly in the early stages.

Near the 1100M, SAPPHIRE STAR (HK Cheng) steadied off the heels of POWER SHAFT (App R Rueven) which was taken outwards by DOCTOR WU which continued to race keenly and switched outwards across the heels of JOYFUL AFFAIR (App KM Lai).

Near the 200M, DOCTOR WU laid inwards, obliging its rider to change his whip from his right hand to the left hand.

Near the 200M, App M Hanif, the rider of MONEY NOT ENOUGH had his whip accidentally struck by the whip of Jockey TM Wan, the rider of DOCTOR WU, resulting in App M Hanif dropping his whip.

Near the 200M, SINAR PELANGI (HS Gill) switched outwards, across the heels of POWER SHAFT which drifted inwards under pressure.

Near the 150M, HEART BY HEART (App L Hernry) was momentarily crowded for room between SAPPHIRE STAR and JOYFUL AFFAIR which laid outwards, obliging its rider to stop and straighten.

Near the winning post, DIAMONDINDRUFF steadied off the heels of JOYFUL AFFAIR.

Post-race veterinary examinations of HOONG WAN, BUKIT FIRE, LEE DANCER and DIAMONDINDRUFF revealed no obvious abnormality.

The Club Veterinary Surgeon reported that VISTA returned broken-winded and will be required to undergo a corrective surgery and 1200M/vet examination before being declared to race again.

When questioned regarding the improved performance of SURPRISE STRIKE, Trainer K Coetzee stated that SURPRISE STRIKE was resuming after a short spell and had been working well recently in trackwork and believed that SURPRISE STRIKE had a chance today, as the gelding was coming down in class in a weaker field. His explanation was noted and his attention was drawn to the Rules regarding 'in-and-out' running.

RACE 9 (R540) M'SIA GROUP 1 – 2400M (lc) PERAK DERBY

ISNOTTHEPRICE (HS Gill) was slowly away.

Shortly after the start, HINT (J De Souza) and TEARS TO DIAMONDS (M Helmy) were crowded for room between LITTLEBITOFJOY (S John) and GOOD SIGHT (MW Teh) which hung in badly. HINT lost ground in this incident and TEARS TO DIAMONDS clipped the heels of GOOD SIGHT, stumbled and lost ground. ISNOTTHEPRICE which was following, steadied off the heels of TEARS TO DIAMONDS. Thereafter, GOOD SIGHT continued to hang inwards approaching the winning post on the first occasion.

From the 700M to the 600M, SPEED BABY (I Azhar) was held up when racing behind AWINNERSGAME and on the inside of WIENER (K Eirwan). Shortly afterwards, SPEED BABY switched outwards across the heels of AWINNERSGAME which commenced to give ground.

MR AMBASSADOR (App Z Khairil) and TEARS TO DIAMONDS raced wide home turn.

SPEED BABY drifted outwards under pressure over the concluding stages of the race.

GOOD SIGHT which hung in badly, will be required to pass a test (1 starting stall) before being declared to race again.

Post-race veterinary examinations of MR AMBASSADOR, AWINNERSGAME and KAMPONG CHANTEK (L Sofhan) revealed no obvious abnormality.

MR AMBASSADOR, AWINNERSGAME, ISNOTTHEPRICE and KAMPONG CHANTEK which all raced poorly, will each be required to pass a test (1000M/vet) before being declared to race again.

RACE 11 (R541) CLASS 5 - 1800M (sc) - GOOD NATURE-2009 HANDICAP

MID SUN, a course scratching which had sustained bruised both fore, will be required to pass a veterinary examination before being declared to race again.

The saddle on DAHLGREN (WK Yan) was re-adjusted behind the barriers.

SPACE INVADER (J Shankar) and GIFT'S DAWAN (App KK Chin) which stood flat-footed and lost considerable ground, will each be required to pass a test (1 starting stall) before being declared to race again.

KING OF THE CREEK (M Helmy) which hung badly on the first turn, will be required to pass a test (1 starting stall) before being declared to race again.

The saddle on GIFT'S DAWAN slipped backwards during the running.

AFFIRMATIVE ACTION (HS Gill) raced wide first turn.

I WISH (App KM Lai) raced wide throughout.

The Club Veterinary Surgeon reported that GIFT'S DAWAN returned with epiglottis entrapment and will be required to undergo corrective surgery and 1000M/vet examination before being declared to race again.

Post-race veterinary examinations of SUNNY STAR (LL Tai), I WISH, SPACE INVADER, AFFIRMATICE ACTION, FLASH GORDON (S John), DAHLGREN and AMARONE (M Wepner) revealed no obvious abnormality.

When questioned regarding the improved performance of KING OF THE CREEK, Trainer R Lines stated that he was surprised with the win today and stated that he removed the tongue-tie and added a special bit on the gelding and believed that may have contributed to the improved performance and also KING OF THE CREEK may have been more suited over a longer distance. His explanation was noted and his attention was drawn to the Rules regarding 'in-and-out' running.

RACE 13 (R542) COMBINED CLASSES 1&2 – 1400M (sc) REGAL TAN-1978 HANDICAP

MAN OF SUBSTANCE, a course scratching which had sustained a stone bruise near fore, will be required to pass a veterinary examination before being declared to race again.

NEW POWER, a course scratching which had sustained a bruised near fore fetlock, will be required to pass a veterinary examination before being declared to race again.

PERFECT STRIDE which was up 20kgs in body weight, MOONLITE SHOWER which was down 15kgs and THE BANK which was down 18kgs, since their last run, were checked by the Club Veterinary Surgeon and were passed fit to start.

Trainers A Selvaratnam and K Hughes were each fined RM250/- under MRA Rule 152(5)(a) for failing to declare the use of special plates on PERFECT STRIDE (J De Souza) and MIGHTY TRIPLE ACE (App M Hanif) respectively.

GUST (HK Cheng) which stood flat-footed, will be required to pass a test (1 starting stall) before being declared to race again.

MOONLITE SHOWER (App KM Lai) jumped awkwardly outwards and bumped APRIL RAIN (J Shankar).

Near the 1000M, APRIL RAIN commenced to race keenly and steadied off the heels of BEAGLE (App Z Khairil).

KING EMPIRE (App KY Yap) and HAPPY REALM (S Salee) raced wide first turn.

EASY FLYING (TO Chang) raced wide home turn.

App KM Lai, the rider of MOONLITE SHOWER reported that his mount was not striding out freely. A post-race veterinary examination of MOONLITE SHOWER revealed no obvious abnormality.

MOONLITE SHOWER and PERFECT STRIDE which both raced poorly, will each be required to pass a test (1000M/vet) before being declared to race again.

Post-race veterinary examinations of PERFECT STRIDE, APRIL RAIN and SNOW FLAME (K Eirwan) revealed no obvious abnormality.

The Club Veterinary Surgeon reported that EASY FLYING returned with heat stress and will be required to pass a test (1000M/vet) before being declared to race again.

RACE 15 (R543) CLASS 5 – 1400M (sc) – KIKO'S RETURN-2008 HANDICAP

SPICE MASTER, a course scratching which had corneal ulcer, will be required to pass a veterinary examination before being declared to race again.

The saddle on THRILL SEEKER (App M Yunes) slipped forward, placing its rider at a disadvantage.

LANCER MAN (HS Gill) jumped awkwardly.

ETERNAL CHEERS (App KC Tham), ESSENTIALLY COOL (App CK Tan), FROM ZERO (App KM Lai) and ROLLING KING (App KK Chin) were all slowly away.

DANCING GREY (A Kumar) raced wide first turn.

Near the 400M, Jockey A Kumar, the rider of DANCING GREY got his whip entangled with his off-side rein.

Near the 400M, HYPER POWER (Lou Ho) switched outwards across the heels of DANCING GREY and LUCKY COMET (M Wepner) in order to obtain clear running.

Near the 350M, LUCKY COMET hung inwards, obliging its rider to stop and straighten.

HYPER POWER laid outwards over the concluding stages of the race.

Near the 200M, ESSENTIALLY COOL laid inwards, obliging its rider to stop and straighten.

Post-race veterinary examinations of ETERNAL CHEERS, DANCING GREY and LANCER MAN revealed no obvious abnormality.

LANCER MAN which raced poorly, will be required to pass a test (1000M/vet) before being declared to race again.

The Club Veterinary Surgeon reported that KNIGHTRIDER (WK Yan) had returned broken-winded and will be required to undergo corrective surgery and 1200M/vet examination before being declared to race again.

When questioned regarding the improved performance of VERY STYLO (HK Cheng), Trainer PK Leong stated that VERY STYLO did not handled the heavy going last start and felt that VERY STYLO would run better on a good track today. His explanation was noted and his attention was drawn to the Rules regarding 'in-and-out' running.

Jockey TM Wan (DARWIN) subsequently exercise his right of appeal against the penalty of four (4) months suspension and fine of RM20,000/- imposed by the Stipendiary Stewards for his ride in the above race.

The Stipendiary Stewards today (21st April 2013) heard an application by Jockey TM Wan for a stay of sentence. After careful consideration and deliberation, the Stipendiary Stewards decided not to grant him a Stay of Sentence. Jockey TM Wan was further advised of his Right of Appeal against the decision of the Stipendiary Stewards to the Racing Stewards.

Jockey TM Wan subsequently exercised his Right of Appeal to the Racing Stewards at and a date for the hearing is to be advised.

RACE 3 (R530) CLASS 5 – 1800M(sc) – CASSINI PARK-1968 HANDICAP 3rd DAY, SATURDAY, 20th APRIL 2013, PERAK APRIL DERBY MEETING 2013

At the conclusion of an inquiry today (21st April 2013), Jockey J De Souza, the rider of BRAVE COMMANDER was found guilty to a charge of careless riding under MRA Rule 44(9)(a)(ii) in that near the 1600M, he allowed his mount BRAVE COMMANDER to shift inwards when insufficiently clear of REGAL KNIGHT (J Shankar), thereby causing that gelding to check and lose ground.

When deciding on penalty, the Stewards took into account Jockey J De Souza's status as a visiting jockey, riding record and mitigating factors. Jockey J De Souza's licence to ride in races was suspended for a period of two (2) Malaysian race days. Acting under the provision of MRA Rule 48(5), the Stewards deferred Jockey De Souza's suspension to commence from Monday, 29th April 2013 and to expire on Sunday, 12th May 2013, both dates inclusive. He was advised of his right of appeal. (6.40pm)

RACE 4 (R531) CLASS 4 – 1800M(sc) – PRINCE OF LALITA-1959 HANDICAP, 3rd DAY, SATURDAY, 20th APRIL 2013, PERAK APRIL DERBY MEETING 2013

At the conclusion of an inquiry today $(21^{st} \text{ April } 2013)$, Jockey H Barnabas, the rider of CARBON COPY pleaded guilty to a charge of careless riding under MRA Rule 44(9)(a)(ii) in that near the 150M, he allowed his mount CARBON COPY to shift outwards when insufficiently clear of RAFFLES PEGASUS (J Shankar), thereby causing that gelding to check and lose ground.

When deciding on penalty, the Stewards took into account Jockey H Barnabas's guilty plea, his forthright evidence and riding record. Jockey H Barnabas's licence to ride in races was suspended for a period of four (4) race days. Acting under the provision of MRA Rule 48(5), the Stewards deferred Jockey Barnabas's suspension to commence from Monday, 29th April 2013 and to expire on Friday, 10th May 2013, both dates inclusive. He was advised of his right of appeal. (11.43am)

RACE 8 (R535) CLASS 4– 1200M(sc) – ON STAGE-1958 HANDICAP 3rd DAY, SATURDAY, 20th APRIL 2013, PERAK APRIL DERBY MEETING 2013

At the conclusion of an inquiry today (21st April 2013), Jockey WK Yan, the rider of BERCHAM pleaded guilty to a charge of careless riding under MRA Rule 44(9)(a)(ii) in that near the 250M, he allowed his mount BERCHAM to shift inwards when insufficiently clear of MARINI WALTZ (Alan Ng), thereby causing that filly to check and lose ground.

When deciding on penalty, the Stewards took into account Jockey WK Yan's guilty plea, his forthright evidence and riding record. Jockey WK Yan's licence to ride in races was suspended for a period of four (4) race days. Acting under the provision of MRA Rule 48(5), the Stewards deferred Jockey Yan's suspension to commence from Monday, 29th April 2013 and to expire on Friday, 10th May 2013, both dates inclusive. He was advised of his right of appeal. (11.17am)
