ZENIDIN (S Sandana) jumped awkwardly.

Jockey C Goon, the rider of NICE HAT TRICK reported that his mount was not striding out freely and racing to the 1050M, the gelding raced ungenerously and lost ground. A post-race veterinary examination of NICE HAT TRICK revealed no obvious abnormality. NICE HAT TRICK which raced poorly, will be required to pass a test (1000M/vet) before being declared to race again.

#### RACE 2 (R501) CLASS 5 - 1400m(lc) - GENEROUS TYCOON-2010 HANDICAP

SEA BUTTERFLY which was down 16kgs in body weight since its last run, was checked by the Club Veterinary Surgeon prior to the race and was passed fit to start.

The Stewards ordered the withdrawal of POWER WIND (WK Yan) at 1.47pm acting on veterinary advice that the gelding was bleeding in its mouth. POWER WIND will be required to pass a veterinary examination before being declared to race again.

PROPITIONS GOLD (CK Tan) was examined behind the barriers by the Club Veterinary Surgeon and was passed fit to start.

EMPEROR QIAN LONG (S Sandana) was slow to begin

SEA BUTTERFLY (App AM Aizat) jumped away awkwardly and stumbled shortly after the start.

App AM Aizat, the rider of SEA BUTTERLY reported that his mount was not striding out freely. A post-race veterinary examination of SEA BUTTERFLY revealed no obvious abnormality.

SEA BUTTERFLY which raced poorly, will be required to pass a test (1000M/vet) before being declared to race again.

A post-race veterinary examination of DARK EXPRESS (C Goon) revealed no obvious abnormality.

The Stewards questioned jockey S Sandana, the rider of EMPEROR QIAN LONG who explained that his instructions were to be handy, but he was unable to carry out the instructions when the horse began awkwardly and was slow into stride. The Stewards were satisfied that after the start, he pushed forward and improved his position, but the Stewards advised him that he should have used more vigour from the 800M until the 400M. No further action was taken.

#### RACE 3 (R502) CLASS 5 – 1400m(lc) – FAST FLYING-2007 HANDICAP

CAMRY, which was up 15kgs in body weight since its last run, was checked by the Club Veterinary Surgeon prior to the race and was passed fit to start.

VALHALLA (F Yap) was slow to begin.

POT BLACK (App I Amirul) which raced poorly, will be required to pass a test (1000M/vet) before being declared to race again. A post-race veterinary examination of POT BLACK revealed no obvious abnormality.

Jockey HS Gill, the rider of WASHINGTON BAY reported that his mount was not striding out freely. A post-race veterinary examination of WASHINGTON BAY revealed that the gelding had returned with respiratory distress and as such, will be required to pass a test (1000M/vet) before being declared to race again.

A post-race veterinary examination of PRINCE ISLANDER (J Shankar) revealed that the gelding had bled and as such, will be barred from racing for a period of three (3) months under MRA Rule 92(3)(a)&(b) and thereafter, will be required to pass a bleeder's test before being declared to race again.

TIGER STRIPES (J De Souza) shifted in at the start onto CAPRICCI PRINCE (J Shankar).

GREEN TRACER (App AM Aizat) over-raced and hung out passing the 800M and as a result, CAPRICCI PRINCE which was also over-racing, took a run to the inside and approaching the 700M, CAPRICCI PRINCE had to be steadied when GREEN TRACER rolled back in.

LOVE EXCEL (SS Vanan) which raced poorly, will be required to pass a test (1000M/vet) before being declared to race again.

A post-race veterinary examination of INVICTUS (J Low) revealed no obvious abnormality.

## RACE 5 (R504) CLASS 4 –1100m (str) – VALAISAN - 1979 HANDICAP

BIRRALEE ROAD (App WK Lee) jumped away awkwardly and stumbled.

BRAVE SISTER (S Sandana) shifted in on jumping away and bumped TREASUREINTHEHEART (J Shankar).

SAM THE MAN (F Yap) was hampered at the start when BIRRALEE ROAD shifted in and BLACK SORCERER (App AM Aizat) shifted out.

OKI OKI (J De Souza) laid out over the concluding stages.

The Stewards concluded an Inquiry into the ride of Jockey F Yap on SAM THE MAN. Evidence was taken from Acting Trainer Nor Azman and a document from Trainer PS Kumaran regarding his riding instruction was tendered during the Inquiry.

Jockey F Yap was found guilty to a charge under MRA Rule 44(10) for failing to ride to the satisfaction of the Stewards in that:

- i) From the 900M to the 300M, he restrained his mount and failed to allow SAM THE MAN to stride out.
- ii) Stewards were not satisfied that he misunderstood the riding instructions given by acting Trainer Nor Azman.

In deciding the penalty, the Stewards took into account Jockey F Yap's disciplinary record and mitigating factors. Jockey F Yap was suspended from riding in races for a period of three (3) months with effect from Monday, 18<sup>th</sup> April 2016 and to expire on 17<sup>th</sup> July 2016, both dates inclusive. In addition, he was also fined a sum of RM10,000/-He was informed of his Right of Appeal (5.50pm).

MR EPIC which was down 15kgs in body weight since its last run, was checked by the Club Veterinary Surgeon prior to the race and was passed fit to start.

ACE SURPRISE (J Shankar), HELLO SAYANG (App KC Wong) and ALIEN (J Low) were all slow to begin.

HEART'S CHOICE (App SU Lim) shifted in under the whip over the 250M.

A post-race veterinary examination of ACE SURPRISE revealed no obvious abnormality. ACE SURPRISE was impounded.

A post-race veterinary examination of LITTLE BUT FIERCE (App SU Lim) revealed no obvious abnormality.

#### **GENERAL REPORT**

INQUIRY INTO THE POST-RACE ANALYSIS OF URINE SAMPLE CODED "19811" TAKEN FROM RACEHORSE "STREET TEASE" (J504) WHICH FINISHED FIRST (1st) IN RACE 4 (R1489) ON SATURDAY, 12th DECEMBER 2015 DURING THE PERAK DECEMBER RACE MEETING 2015, WHICH RETURNED POSITIVE TO "MORPHINE", A PROHIBITED SUBSTANCE UNDER MRA RULES OF RACING.

The Stipendiary Stewards yesterday, Friday, 15<sup>th</sup> April 2016 concluded an Inquiry into the above matter.

Evidence was taken from Trainer Prakhash Pereira, the trainer of STREET TEASE, Veterinary Surgeon, PRTC, Dr. Reza Singam and Professor Dr. Tan Soo Choon, Chief Analyst and his Assistant, Ms Chan Sue Hay, USains Biomics Sdn Bhd.

Trainer Prakhash Pereira was found guilty to a charge under MRA Rule 134(6)(a) as read with MRA Rule 134(13) and punishable under MRA Rule 134(7) in that he, as the Trainer and person responsible for accepting to race **STREET TEASE** in the above race, which finished 1<sup>st</sup> placing and its post-race urine sample coded "19811" subsequently upon analysis had returned positive to **morphine**, a prohibited substance under the MRA Rules.

When deciding on penalty, the Stewards took into account Trainer Prakhash Pereira's mitigating factors, disciplinary records under the same Rule and the seriousness of the drug involved. Trainer Prakhash Pereira was disqualified for a period of six (6) months with immediate effect, i.e. Friday, 15<sup>th</sup> April 2016 and to expire on Friday, 14<sup>th</sup> October 2016, both dates inclusive. In addition, he was also fined a sum of RM50,000/-(Malaysian Ringgit: Fifty Thousand only).

In terms of MRA Rule 134(11), STREET TEASE was disqualified from the above race and the results will be amended accordingly.

Trainer Prakhash Pereira left the course before the above penalty could be imposed. The Stewards made efforts to contact him via telephone and instructed him to return to the Inquiry Room. Trainer Prakhash Pereira ignored the instruction and advised the Stewards to conclude the Inquiry in his absence. Subsequently, the Stewards tried to notify him of the above penalty via telephone, however he requested the Stewards to notify him by computer (email) and hung up the call.

The Stewards acceded to his requests and Trainer Prakhash Pereira has the Right of Appeal (5.35pm).
