RACE 1 (R715) CLASS 5 – 1200m(lc) – NEW NORFOLK HANDICAP

Acting on veterinary advice that CAMRY (J De Souza) was lame near fore, the Stewards ordered the withdrawal of the gelding at 1.35pm. CAMRY will be required to pass a test (1000M/vet) before being declared to race again.

VISTA (J Low) shifted in on jumping away and bumped LEE'S MELODY (SS Vanan) and continued to lay in, resulting in LEE'S MELODY brushing the hind quarters of RACING MAN (App S Saddam). LEE'S MELODY lost its position as a consequence.

OZZY (App KC Wong) raced ungenerously in the early and middle stages of the race.

EL COMANDANTE (App J Daniel) had to be steadied racing to the 400M when BERNI DANCER (Lou Ho) rolled out.

RUMPELSTILTSKIN (App C Goolgar) rolled out at the 350M, taking CASPER (J Shankar) wider on the track.

App C Goolgar, the rider of RUMPELSTILTSKIN would be referred to the Perak Turf Club Apprentice Academy for further instructions.

Post-race veterinary examinations of BERNI DANCER and LEE'S MELODY revealed no obvious abnormality.

RACE 2 (R716) CLASS 5 – 1200m(lc) – RICHMOND HANDICAP

TEEN ANGEL (J Low) was slow to begin.

Jockey S Salee, the rider of BAZINGA reported that his mount was not striding out freely. A post-race veterinary examination of BAZINGA revealed no obvious abnormality.

Post-race veterinary examinations of BLAZING STEED (TM Wan) revealed no obvious abnormality and WASHINGTON BAY (KT Cheng) returned with respiratory distress. As such, WASHINGTON BAY will be required to pass a test (1000M/vet) before being declared to race again.

The state of track was upgraded to "Yielding" after the running of this race.

RACE 3 (R717) OPEN MAIDEN (WFA) – 1200m(lc) – KINGSTON HANDICAP

HUMMING BIRD, a course scratching as it had a bruised near fore, will be required to pass a veterinary examination before being declared to race again.

GREAT GERONIMO which was up 36kgs and D'GREAT EMINENCE which was down 19kgs in body weight since their last run, were checked by the Club Veterinary Surgeon prior to the race and were passed fit to start.

ARCHAELOGY (App Z Khairil) which stood and was slow to begin, losing considerable ground, will be required to pass one starting stall test before being declared to race again.

EYEOFTHETIGER (App P Mogun) shifted out from the 200M, finishing very wide on the track. App P Mogun was shown the vision of the race in the presence of his master Trainer S Cook and was advised that he would be referred to the Perak Turf Club Apprentice Academy.

Post-race veterinary examinations of ARCHAELOGY and D'GREAT EMINENCE (C Goon) revealed no obvious abnormality.

The Club Veterinary Surgeon reported that DON'T FORGET THIS (KT Cheng) returned having cast its off hind plate and sustained a cut to its near fore cannon. As such, the gelding will be required to pass a veterinary examination before being declared to race again.

App P Mogun, the rider of EYEOFTHETIGER in the presence of his master, Trainer S Cook was fined RM2,000/- under MRA Rule 44(12) for making an unacceptable gesture prior to the winning post.

RACE 4 (R718) CLASS 4 – 1600m (lc) – DEVONPORT HANDICAP

GET THE LOTSKI and LA FAMILIA, both course scratching as they had fever and colic respectively, will each be required to pass a veterinary examination before being declared to race again.

Acting on veterinary advice that ONE CUT ABOVE (Lou Ho) was lame near fore, the Stewards ordered the withdrawal of the gelding at 3.19pm. ONE CUT ABOVE will be required to pass a test (1000M/vet) before being declared to race again.

IWA ANTILIA (App KC Wong) was slow to begin.

THE THINKER (App M Hanif) had to be steadied racing to the 350M to avoid the heels of APRIL RAIN (CK Tan).

NANA (App Z Khairil) had to be steadied to avoid the heels of CANDY CRUSH (WK Yan) racing to the 100M and shifted out to obtain a clear run.

App M Hanif, the rider of THE THINKER reported that his mount was not striding out freely. A post-race veterinary examination of THE THINKER revealed no obvious abnormality.

The Club Veterinary Surgeon reported that MAL'S DAD (App AM Aizat) returned having cast its near fore plate.

Post-race veterinary examinations of HALO INSPIRE (J De Souza) and CANDY CRUSH (WK Yan) revealed no obvious abnormality.

RACE 5 (R719) CLASS 5 –1800m (sc) – ULVERSTONE HANDICAP

BOWEN LAD (R Olechea) which was over-racing, had to be steadied to avoid the heels of GREAT PRINCE (App M Rashpassing) passing the winning post on the first occasion and lost ground.

KING OF THE CREEK (J Low) was caught wide from the winning post until entering the backstraight.

Jockey S Sandana, the rider of PISCES GEM reported that his mount was not striding out freely. A post-race veterinary examination of PISCES GEM and LEAP OF FAITH (CK Tan) revealed no obvious abnormality.

RACE 6 (R720) CLASS 5 – 1800m (sc) – SOMERSET HANDICAP

After passing the winning post on the first occasion, FEARED (Y Aify) which was racing on the fence, was tightened inside of JETSTAR EAGLE (App KC Tham), causing these two horses to brush. As a result, JETSTAR EAGLE shifted out, bumping BLUE DELAGO (Lou Ho) which in turn shifted out and bumped KING FAALCON (R Olechea), resulting in R Olechea losing his stirrup irons and becoming severely unbalanced. R Olechea lost the use of both stirrup irons until the 1200M. The Stewards took no further action as they consider it a racing incident.

Post-race veterinary examinations of LUCK DRAGON (App SU Lim) and KING FAALCON revealed no obvious abnormality.

RACE 7 (R721) ENRICH STAKES A – 1400m (sc) TASMANIAN TURF CLUB GOODWILL TROPHY [SET-WEIGHT]

STORMY BRUCE, a course scratching as it had respiratory allergy, will be required to pass a veterinary examination before being declared to race again.

TRIPLE ONE D'BEST which was down 27kgs in body weight since its last run, was checked by the Club Veterinary Surgeon prior to the race and was passed fit to start.

GOLIATH (C Goon) had to be checked racing to the 1300M to avoid the heels of TILSWORTH FREDDIE (TM Wan).

ALL SERENE (S Thai Yang) had to be checked to avoid the heels of SUPER CROWN (App SU Lim) racing to the 1200M. Shortly after this incident, MR PAULANDIT (S Salee) had to be checked to avoid the heels of GOLIATH which had to be steadied to avoid the heels of the runners in front.

Jockey Lou Ho, the rider of STREET DREAM reported that his mount was not striding out freely. A post-race veterinary examination of STREET DREAM revealed that the horse had returned lame both hind and as such, will be required to pass a test (1000M/vet) before being declared to race again.

A post-race veterinary examination of BRAVE MALALA (App KC Wong) revealed no obvious abnormality.

RACE 8 (R722) CLASS 4 – 1200m (sc) – LAUNCESTON HANDICAP

JAZZ IT UP which was down 22kgs and UNCLE GLORY which was up 19kgs in body weight since their last run, were checked by the Club Veterinary Surgeon prior to the race and were passed fit to start.

SEE FOR YOURSELF (App M Hanif) had to be checked to avoid the heels of JAZZ IT UP (C Goon) racing to the 50M when JAZZ IT UP was taken in by OUR CHICK MAN (Lou Ho).

At the conclusion of an Inquiry today, Jockey Lou Ho, the rider of OUR CHICK MAN pleaded guilty to a charge of careless riding under MRA Rule 44(9)(a)(ii) in that whilst riding OUR CHICK MAN, he allowed his mount to shift in at about the 50M when insufficiently clear of JAZZ IT UP, resulting in JAZZ IT UP being carried inward onto SEE FOR YOURSELF which had to be checked.

When deciding on the penalty, the Stewards took into consideration Jockey Lou Ho's riding record and mitigating factors. He was suspended from riding in races for a period of two (2) Malaysian race days. Acting on the provisions of MRA Rule 48(5), the Stewards deferred the commencement of Jockey Lou Ho's suspension to take effect from Monday, 13th June 2016 and to expire on Sunday, 19th June 2016, both dates inclusive. He was advised of his right of appeal (6.00pm).

Jockey J Shankar, the rider of HENNESSY DRAGON reported that his mount was not striding out freely. A post-race veterinary examination of HENNESSY DRAGON revealed no obvious abnormality.

The Club Veterinary Surgeon reported that JAZZ IT UP returned having cast its off hind plate.

GENERAL REPORT

RACE 5 (R686) COSMO C –1200m (sc) – WALTZING MATILDA STAKES PERAK MAY MEETING 2016 – 1st DAY, SATURDAY, 28th MAY 2016

The Stewards on Tuesday, 31st May 2016 concluded an Inquiry into the running of GREAT SCOTT, ridden by App J Daniel in the above race.

Evidence were taken from Mr. KL Chong, the trainer of GREAT SCOTT and App J Daniel, the rider of GREAT SCOTT.

After reviewing the video of the race and taking all evidence into consideration, App J Daniel pleaded guilty to a charge for careless riding under MRA Rule 44(9)(a)(ii). The particulars of the charge were that whilst riding GREAT SCOTT from about the 200M, he allowed his mount to continue shifting outwards when being ridden with the whip, resulting in BIG LIGHTNING (J Shankar) being taken wider on the track and losing his iron and becoming unbalanced.

In assessing the penalty, the Stewards took into consideration App J Daniel's guilty plea, mitigating factors and his clean record. App J Daniel was suspended from riding in races for a period of two (2) Malaysian race days.

Acting on the provisions of MRA Rule 48(5), the Stewards deferred the commencement of App J Daniel's suspension to take effect from Sunday, 5th June 2016 and to expire on Saturday, 11th June 2016, both dates inclusive. He was advised of his right of appeal (10.40 am).

RACE 5 (R686) COSMO C –1200m (sc) – WALTZING MATILDA STAKES PERAK MAY MEETING 2016 – 1st DAY, SATURDAY, 28th MAY 2016

After reviewing the video footage behind the barriers regarding Jockey CK Tan's whip use on APRIL RAIN, the Stewards took no further action.

PRTC OFFICIAL RACE TRIAL – TUESDAY, 31st MAY 2016

DRAGON KNIGHT (J390) which returned lame off fore after the official race trial on Tuesday, 31st May 2016 at Perak Turf Club, will be required to pass a test (1000M/vet) before being declared to race again.

The Stewards opened an investigation today (Saturday, 4th June 2016) into an alleged incident in the Jockeys' Room between Jockey J Shankar and App P Mogun. The investigation was adjourned to a date to be fixed.
