**RACE 1 (R1438) CLASS 5 – 1600m(lc) - WORLD COURT 1989 HANDICAP**

PERFECT FIXER, a course scratching as it had sustained multiple injuries whilst being loaded into a float, will be required to pass a veterinary examination before being declared to race again.

TESSERACT (J Low) and LEAP OF FAITH (CK Tan) both over-raced in the early stages of the race.

Post-race veterinary examinations of GENERAL G (Y Aify) revealed no obvious abnormality and AMONGST THE STARS (F Yap) revealed that the gelding had returned lame near hind and as such, AMONGST THE STARS will be required to pass a test (1000M/vet) before being declared to race again.

The Club Veterinary Surgeon reported that DUEL OF HONOUR (Lou Ho) returned having cast its near hind plate.

## **RACE 2 (R1439) CLASS 5 –1600m(lc) – MITAVITE XLR8 HANDICAP**

BOWEN BOY, a course scratching as it had sustained a float injury whilst being loaded into a float, will be required to pass a veterinary examination before being declared to race again.

Trainer R Jensen was fined RM250/- for negligence under MRA Rule 152(5)(a) for failing to seek the Stewards' permission to remove blinkers on PATERSON ROAD (App AM Aizat) within the stipulated time.

IWA ANTILIA (KT Cheng) and FAIRBORN (F Yap) were both slow to begin.

Racing to the 400M, HARDCORE ROCK (M Yusri) shifted out, taking FAIRBORN wider and racing to the 300M, Jockey M Yusri, the rider of HARDCORE ROCK had to stop riding and straighten the gelding.

Post-race veterinary examinations of IWA ANTILIA and D'GREAT WORLD (J Low) revealed no obvious abnormality.

## **RACE 3 (R1440) COSMO B – 1200m(lc) - MITAVITE CUP [SET WEIGHTS]**

EYEOFTHETIGER, a course scratching as it had sustained a bruised off knee, will be required to pass a veterinary examination before being declared to race again.

PISCES STAR which was up 20kgs and FRAAJILISTIC which was down 41kgs in body weight since their last runs, were checked by the Club Veterinary Surgeon prior to the race and were passed fit to start.

At the conclusion of an Inquiry today, App CT Lee, the rider of LEMON LAW in the presence of his acting master, Trainer Jerome Tan, pleaded guilty to a charge of careless riding under MRA Rule 44(9)(a)(ii) in that whilst riding LEMON LAW, he shifted in when insufficiently clear of RIGHT TIMING (HK Cheng), causing that gelding to brush the rail and had to be checked.

In deciding the penalty, the Stewards took into account App CT Lee's guilty plea and disciplinary record. App CT Lee was suspended from riding in races for a period of three (3) race days. Acting on the provisions of MRA Rule 48(5), the Stewards deferred the commencement of App CT Lee's suspension to take effect from Sunday, 20<sup>th</sup> November 2016 and to expire on Saturday, 3<sup>rd</sup> December 2016, both dates inclusive. He was advised of his right of appeal (4.00pm).

At the conclusion of an Inquiry today, Jockey F Yap, the rider of HEART'S CHOICE was found guilty to a charge of careless riding under MRA Rule 44(9)(a)(ii) in that whilst riding the gelding shortly after the start, he shifted in abruptly when insufficiently clear, thereby causing varying degrees of interference to the following runners:-

ALL SERENE (C Goon), CALIFORNIA CAT (App T Krisna), FRAAJILISTIC (CK Tan), TEN SENSE WIN (S Sandana), FIELD FORCE (KT Cheng), RIGHT TIMING (HK Cheng), LUCKY DAPPER (App AM Aizat), and LEMON LAW (App CT Lee).

In deciding the penalty, the Stewards took into account his disciplinary record and mitigating factors. Jockey F Yap was suspended from riding in races for a period of four (4) race days. Acting on the provisions of MRA Rule 48(5), the Stewards deferred the commencement of Jockey F Yap's suspension to take effect from Sunday, 20<sup>th</sup> November 2016 and to expire on Saturday, 10<sup>th</sup> December 2016, both dates inclusive. He was advised of his right of appeal (4.40pm)

Post-race veterinary examinations of FIELD FORCE and RIGHT TIMING revealed obvious abnormality.

#### **RACE 4 (R1441) TAN SRI DAVID V. JEYARATNAM CHARITY CUP – 1400m(lc) [SET-WEIGHTS]**

GOODFELLAS, a course scratching as it had sustained a bruised near hind sole, will be required to pass a veterinary examination before being declared to race again.

HOLY EMPIRE (S Salee) and PEACEFUL WARRIOR (R Woodworth) were slow to begin.

LUCK SUCCESS (App SU Lim) jumped awkwardly outwards.

AUDACIOUS (M Yusri) raced wide from the 800M until entering the straight.

TIDAL WAVE (App AM Aizat) laid out racing to the 400M, taking LUCK SUCCESS wider on the track.

Racing to the 300M, TIDAL WAVE had to steady when LUCK SUCCESS laid in and shifted out to obtain a clear run.

Post-race veterinary examinations of BLACK AND WHITE (C Goon) and AUDACIOUS revealed no obvious abnormality. However, a post-race veterinary examination of CANDY CRUSH (CK Tan) revealed that the gelding had returned with a

cut to its near fore cannon. CANDY CRUSH will be required to pass a veterinary examination before being declared to race again.

**RACE 5 (R1442) MALAYSIA GROUP 1 -1600m (1c) – PERAK CORONATION CUP [3 YEAR OLDS & ABOVE] [SET-WEIGHTS]**

GOOD BABY which was down 19kgs in body weight since its last run, was checked by the Club Veterinary Surgeon prior to the race and was passed fit to start.

Racing to the 400M, AL VALORE (R Woodworth) shifted away from TRIPLE ONE D’BEST (Y Aify), resulting in EN LAUDER (J Low) being taken out onto TRUSON (Lou Ho) which was forced wider.

Racing to the 150M, JUSTICE WORLD (App T Krisna) laid out and as a result, the rider had to stop and straighten the gelding.

Jockey F Yap, the rider of GOOD BABY dropped his whip at about the 400M and was warned that a repetition may lead to action being taken against him.

Jockey R Woodworth, the rider of AL VALORE had his whip accidentally knocked off his hand at about the 300M by Jockey Y Aify, the rider of TRIPLE ONE D’BEST.

App SU Lim, the rider of BEAUTIFUL CHOICE reported that his mount was not striding out freely. A post-race veterinary examination of BEAUTIFUL CHOICE revealed that the gelding had returned lame near fore and as such, will be required to pass a test (1000M/vet) before being declared to race again.

Post-race veterinary examinations of GOOD BABY (F Yap) and EN LAUDER (J Low) revealed no obvious abnormality and both these geldings were impounded.

Post-race veterinary examinations of HARRYS PAL (L Sofhan) and GHOST HANA (HS Gill) revealed no obvious abnormality. TRIPLE ONE D’BEST (Y Aify) returned lame near fore and as such, will be required to pass a test (1000M/vet) before being declared to race again.

**RACE 6 (R1443) RESTRICTED MAIDEN – 1200m(lc)  
EQUINE INTERNATIONAL AIRFREIGHT TROPHY [3 YEAR OLDS ONLY]  
[WEIGHT-FOR-AGE]**

Acting on veterinary advice that DAHEES (S Sandana) was kicked on its left side behind the barriers and had sustained bruises, the Stewards ordered its withdrawal at 4.31pm. DAHEES will be required to pass a veterinary examination before being declared to race again.

SUGAR BABY (CK Tan) jumped away awkwardly outwards and was slow to begin.

JABBAR (S Salee) jumped away awkwardly inwards and bumped BAHAR (R Woodworth).

COVER MAN (App CT Lee) shifted out on jumping away, carrying SYMBOLIC GESTURE (HK Cheng) onto DETERMINE TO WIN (App WK Lee), resulting in BAHAR being tightened onto JABBAR and causing BAHAR to lose its position. Shortly after that, JABBAR raced greenly, shifted in away from MULTIBLUE RANCHO (KT Cheng). Shortly thereafter, DETERMINE TO WIN shifted in abruptly and bumped COVER MAN, causing COVER MAN to become unbalanced.

SUGAR BABY raced wide throughout the race.

Passing the 400M, PORSENCE (App KC Wong) rolled in, resulting in SYMBOLIC GESTURE having to be steadied. After this incident, PORSENCE continued to race greenly.

Racing to the 100M, SUGAR BABY raced greenly and shifted in, resulting in MULTIBLUE TOSCA (App M Sathiaa) having to be steadied and shifted out. In this incident, the saddle on MULTIBLUE TOSCA slipped back, placing the rider at a disadvantage in his riding.

App WK Lee, rider of DETERMINE TO WIN reported that his mount did not act in the going and dipped on several occasions in the race.

A post-race veterinary examination of SUGAR BABY revealed no obvious abnormality.

#### **RACE 7 (R1444) CLASS 5 – 1600m (lc) – WINNING TOUCH 1992 HANDICAP**

Jockey F Yap was certified unwell by the Club Medical Officer and was stood down. As there was no suitable replacement rider available to the connection's of JETSTAR EAGLE, the Racing Stewards permitted the withdrawal of JETSTAR EAGLE under MRA Rule 105(4).

GOOD GIFT (S Sandana) jumped awkwardly inwards and bumped FLYING HORSE (R Woodworth) which in turn, bumped ROCKET EXPRESS (J Chuah).

Approaching the 150M, ALL WEALTH (L Sofhan) had to be steadied to avoid the heels of ALACARTE (J Low) and was disappointed for a run.

Over the final 75M, GRAND SHOW (App AM Aizat) shifted out and JACKWIN (App SU Lim) shifted in, resulting in FIRE GENERAL (HS Gill) racing between them, being tightened for room and having to be steadied approaching the finish. The Stewards were unable to attribute blame to any rider.

Post-race veterinary examinations of ALACARTE, ALL WEALTH and GOOD GIFT revealed no obvious abnormality.

Prior to the 'All Clear' being given, objections were lodged by Jockey HS Gill, the rider of FIRE GENERAL placed 4<sup>th</sup> against GRAND SHOW being declared the winner and JACKWIN being placed 2nd on grounds of alleged interference at the final 100M. After considering all the evidence, the Racing Stewards were of the opinion that the alleged interference had not affected the result of the race. The objections were overruled and the results stood.

**RACE 8 (R1445) CLASS 4 – 1600m (lc) - MITAVITE STUDGRO HANDICAP**

BIG BIT COIN, a course scratching as it had respiratory allergy, will be required to pass a veterinary examination before being declared to race again.

Trainer R Jensen was fined RM100/- under MRA 65(5)(c) for failing to produce the declared colours on SUPER VICTORY (App AM Aizat).

ACOUSTIC (App SU Lim) jumped away awkwardly.

App SU Lim, the rider of ACOUSTIC reported that his mount was not striding out freely. A post-race veterinary examination of ACOUSTIC revealed no obvious abnormality.

A post-race veterinary examination of BLUE HILLS (App CT Lee) revealed that the gelding had returned broken-winded and as such, BLUE HILLS will be required to pass a test (1000M/vet) before being declared to race again.

**WITHDRAWAL OF AN APPEAL FROM JOCKEY LOU HO AGAINST THE ONE MONTH SUSPENSION IMPOSED BY THE STIPENDIARY STEWARDS UNDER MRA RULE 44(6) IN CONNECTION WITH HIS RIDING & HANDLING OF “BERNI DANCER” IN RACE 7 (R1265), CLASS 5 – 1400M(sc) HIBISCUS HANDICAP, SATURDAY, 8<sup>th</sup> OCTOBER 2016, PERAK OCTOBER MEETING 2016.**

The Perak Turf Club Racing Stewards today (13<sup>th</sup> November 2016) acceded to Jockey Lou Ho’s application to withdraw his appeal on the above matter. Jockey Lou Ho’s suspension will take effect from tomorrow, Monday, 14<sup>th</sup> November 2016 and will expire on Tuesday, 13<sup>th</sup> December 2016, both dates inclusive. His deposit was forfeited.

The Stewards showed App AM Aizat, the rider of MAZANDARAN the video of the race in the presence of his acting master, Trainer K Coetzee and was warned that he must ride all his mounts out to the end of the race as required under the Rules.
