**STIPENDIARY STEWARDS' REPORT
PERAK DECEMBER MEETING 2016 – SATURDAY, 10th DECEMBER 2016**

STATE OF TRACK: Good

Panel of Stipendiary Stewards:

RACE 1 (R1544) CLASS 5 – 1400m(lc) - LAST CHANCE HANDICAP

JACKPOT, a course scratching as it had sustained a bruised off fore fetlock, will be required to pass a veterinary examination before being declared to race again.

STAR BEAUTY which was up 17kgs in body weight since its last run, was checked by the Club Veterinary Surgeon prior to the race and was passed fit to start.

STAR BEAUTY (App M Sathiaa) was slow to begin.

KIM SALUTE (HS Gill) laid out over the concluding stages.

Over the concluding stages, GOLD COAST CAPTAIN (J Low) had to be steadied when KIM SALUTE shifted out and CHINESE STREET (App SU Lim) shifted in slightly.

Jockey Y Aify, the rider of CLAIM reported that his mount was not striding out freely. A post-race veterinary examination of CLAIM revealed no obvious abnormality.

Post-race veterinary examinations of RACING MAN (App S Saddam) and MARINI WALTZ (S Sandana) revealed no obvious abnormality.

The Stewards questioned Jockey S Sandana, the rider of MARINI WALTZ into his ride on the mare and as to why he raced wide from the backstraight until entering the homestraight and shifted out from the top of the straight and finished the race wide. Jockey S Sandana explained that the mare had raced keenly in the early stages and commenced to hang out and thereafter raced wider than he had anticipated. The Stewards showed Jockey S Sandana the vision of the race and advised him that in future, he should make a greater effort to ensure that his mounts raced closer to the rails under similar circumstances.

RACE 2 (R1545) CLASS 5 –1400m(lc) – SEASON ENDER HANDICAP

MAYWEATHER (M Yusri) shifted in on jumping away, resulting in ZAC SUGGESTION (S Thai Yang) being taken in and bumped on several occasions by SING ENERGY (HS Gill).

ALI BABA (App M Sathiaa) which raced poorly, will be required to pass a test (1000M/vet) before being declared to race again.

Post-race veterinary examinations of BUKIT BINTANG (J Low), SING ENERGY LIGHTNING ROD (App S Saddam) and ALI BABA revealed no obvious abnormality.

The Club Veterinary Surgeon reported that TEEN ANGEL (App WK Lee) returned having cast both fore plates.

RACE 3 (R1546) CLASS 5 – 1400m(lc) - COURSE LIMIT HANDICAP

KUANTAN HILL, BIG EGO and DUE HOME, all course scratchings as they all had sustained bruised near fore sole, will each be required to pass a veterinary examination before being declared to race again.

Trainer KL Chong was advised that a warning has been placed on WHISPERIN THE WIND (App KC Wong) regarding its barrier manners and take steps to improve it, failing which action will be taken in future.

D’GREAT SWIFT (App S Saddam) was slow to begin.

JACKWIN (App SU Lim) which raced poorly, will be required to pass a test (1000M/vet) before being declared to race again.

App SU Lim, the rider of JACKWIN reported that his mount was not striding out freely. Post-race veterinary examinations of JACKWIN and ENLIGHTEN KNIGHT (HS Gill) revealed no obvious abnormality.

The Stewards questioned Trainer KL Chong as to the improved performance of WHISPERIN THE WIND as opposed to its last start in Penang and he stated that the last start in Penang, the gelding failed to act in the heavy going. His explanation was noted.

RACE 4 (R1547) CLASS 4 - 1600m(lc) – RACE-TO-THE-FINISH HANDICAP

GLORY AGE which was up 15kgs in body weight since its last run, was checked by the Club Veterinary Surgeon prior to the race and was passed fit to start.

Trainer Nor Azman was fined RM250/- for negligence under MRA Rule 152(5)(a) for failing to declare the use of an ear muff on AVANTI (App M Sathiaa) within the stipulated time.

NATURE IS NATURE (KT Cheng) was slow to begin and showed no early pace.

SUGAR BABY (CK Tan) was also slow to begin.

Post-race veterinary examinations of HELLO SAYANG (App KC Wong) and SUGAR BABY revealed no obvious abnormality.

The Stewards questioned Trainer Peter Lee as to the apparent poor performance of SUGAR BABY today. He stated that the filly was running up in distance from 1400m to 1600m and Class 4 and he was disappointed with its performance. His explanation was noted.

RACE 5 (R1548) ENRICH STAKES A –1600m (1c) – CONCLUDING CHAPTER STAKES [SET WEIGHTS]

GHOST EMPEROR, a course scratching as it was lame near fore, will be required to pass a test (1000M/Vet) before being declared to race again.

ONLY YOU, a course scratching as it had sustained bruised right knee, will be required to pass a veterinary examination before being declared to race again.

Trainer Nor Azman was fined RM100/- under MRA 65(5)(c) for failing to produce the declared colours on RIGHT TIMING (J Low).

BRAVE MALALA (CK Tan) shifted in under the whip from the 250M to the 200M.

RACE 6 (R1549) CLASS 5 – 1200m(1c) – ULTIMATE CHALLENGE HANDICAP

CROWN TREASURE which was up 24kgs in body weight since its last run, was checked by the Club Veterinary Surgeon prior to the race and was passed fit to start.

POT BLACK (App KC Wong) was slow to begin.

POT BLACK which returned lame near fore, will be required to pass a test (1000M/vet) before being declared to race again.

The Club Veterinary Surgeon reported that BLAZING STEED had bled from both nostrils and as such, the gelding will be barred from racing for a period of three (3) months under MRA Rule 92(3)(a)(b)&(c) and thereafter will be required to pass a Bleeder's test before being declared to race again.

The Stewards questioned Trainer Evert Van Breukelen, the trainer of DARK EXPRESS and App S Saddam, the rider of DARK EXPRESS into the riding tactics adopted on the gelding. Trainer Evert Van Breukelen stated that his instructions were to be forward, but he was surprised that DARK EXPRESS got so far in front of the field. App S Saddam confirmed the instructions and stated that after jumping out of the barrier, the gelding raced fiercely and he was unable to settle DARK EXPRESS, however he had not

intended to get that far in front. The Stewards showed App S Saddam and Trainer Evert Van Breukelen the film and advised App S Saddam that in future, he must ride with much more judgment than he did on this occasion.

RACE 7 (R1550) INITIATION – 1200m (lc) – FINISHING TOUCHES STAKES

MULTIBLUE TOSCA, a course scratching as it had sustained a bruised near fore sole, will be required to pass a veterinary examination before being declared to race again.

MONTE CARLO, EAGLE SOAR and STEEL CUTTER which were down 24kgs, 18kgs and 17kgs respectively and V RESPECT U which was up 26kgs in body weight, since their last run, were all checked by the Club Veterinary Surgeon prior to the race and were passed fit to start.

Trainer R Lines was fined RM100/- under MRA 65(5)(c) for failing to produce the declared colours on MONTE CARLO (J Low).

BLIXEM (App Z Khairil) was examined behind the barriers by the Club Veterinary Surgeon and was passed fit to start.

CIZEN (S Sandana) jumped away awkwardly.

EAGLE SOAR (App T Krisna) was slow to begin.

Passing the 1000M, V RESPECT U (App S Saddam) brushed the running rails over a short distance and shortly thereafter, MASTER OF SUCCESS (App SU Lim) raced greenly and became unbalanced for a few strides.

CALMBEFORETHESTORM (S Thai Yang) which raced greenly at the 900M, shifted in and tightened PORSENCE (HS Gill) onto CIZEN which had to be checked. The Stewards deemed it a racing incident and no further action was taken.

STEEL CUTTER (Y Aify) shifted in very abruptly at the 400M and continued to race very greenly for the remainder of the straight.

Post-race veterinary examinations of MASTER OF SUCCESS, CALMBEFORETHESTORM and CIZEN revealed no obvious abnormality.

The Club Veterinary Surgeon reported that EAGLE SOAR returned having cast its off fore plate.

RACE 8 (R1551) CLASS 5 – 1800m (sc) - GRAND FINALE HANDICAP

FLY NOW which was down 15kgs in body weight since its last run, was checked by the Club Veterinary Surgeon prior to the race and was passed fit to start.

BALBOA (HS Gill) jumped away awkwardly.

MAL'S DAD (C Goon) and JETSTAR EAGLE (M Yusri) were both slow to begin.

Passing the winning post for the first occasion, PURE RABID (Y Aify) had to be steadied and got its head up.

DUEL OF HONOUR (J Low) over-raced in the early stages of the race.

MAL'S DAD raced wide throughout the race.

FLY NOW (HK Cheng) which was weakening, had to be steadied to avoid the heels of IWA ANTILIA (KT Cheng) racing to the 400M when IWA ANTILIA rolled in.

Post-race veterinary examinations of MAL'S DAD, PURE RABID and LEAP OF FAITH (App KC Wong) revealed no obvious abnormality.

At the conclusion of an Inquiry, App SU Lim, the rider of LUCK DRAGON in the presence of his acting master, Trainer Nor Azman, pleaded guilty to a charge under MRA Rule 152(5)(a) for negligence in that he dropped his whip at the final 50M and was fined the sum of RM1,000/-. He was advised of his right of appeal (4.20pm).

RUFFLE THE RUFFIAN (App Z Khairil) jumped away awkwardly and was slow into stride.

RUSH (C Goon) and ACE SURPRISE (App WK Lee) raced wide from the 800M until entering the straight.

Post-race veterinary examinations of I'M A GENIUS (M Yusri) revealed no obvious abnormality, ACE SURPRISE returned broken-winded and RUSH returned lame near hind. As such, ACE SURPRISE and RUSH will each be required to pass a test (1000m/Vet) before being declared to race again.

LEE'S SURPRISE (SS Vanan) raced wide from the 700M until entering the straight.

Racing inside the 300m, App KC Wong, the rider of LUCK TREASURE dropped his off side rein for a short distance.

Post-race veterinary examinations of LEE'S SURPRISE, ZAC GALLANT (S Salee) and LUCK TREASURE revealed no obvious abnormality.

RACE 11 (R1554) CLASS 5 – 1200m (sc) - FIXTURES WRAPPER HANDICAP

D’CREATOR (M Yusri) was slow to begin.

FLUTZ (HK Cheng) shifted out on jumping away, taking CHARLIE CAME ALONG (App M Sathiaa) wider.

Jockey HS Gill, the rider of WASHINGTON BAY reported that his mount was not striding out freely. A post-race veterinary examination of WASHINGTON BAY revealed that the gelding had returned lame off hind and as such, WASHINGTON BAY will be required to pass a test (1000M/vet) before being declared to race again.

Post-race veterinary examinations of FLUTZ and D’CREATOR revealed no obvious abnormality.

The Stewards questioned Jockey HK Cheng, the rider of FLUTZ and Trainer K Coetzee, the trainer of FLUTZ into its apparent poor performance. Jockey HK Cheng stated that his instructions were to be midfield, which were confirmed by Trainer K Coetzee. Jockey HK Cheng stated that the gelding began well and he was able to carry out his instructions, however, he felt that the gelding failed to handle the track condition and was disappointing when placed under pressure. Trainer K Coetzee was of the opinion that other than racing with a stronger field today, he was unable to offer any tangible explanations to the gelding’s poor performance.

When questioned regarding the poor performance of D’CREATOR, Trainer K Coetzee stated that the riding instructions for D’CREATOR were to be handy. However, D’CREATOR was slow to begin. The gelding had been working well with blinkers and he was surprised when the gelding was slow to begin and unable to race more forward as he anticipated. Trainer K Coetzee was disappointed with the gelding’s poor performance. His explanation was noted.

RACE 12 (R1555) CLASS 4 – 1200m (sc) - HAPPY HOLIDAYS HANDICAP

WAR LORD, a course scratching as it had respiratory allergy, will be required to pass a veterinary examination before being declared to race again.

SERPICO which was up 17kgs in body weight since its last run, was checked by the Club Veterinary Surgeon prior to the race and was passed fit to start.

ACOUSTIC (CK Tan) got its head down when the gates were released and was slow to begin.

CLASSIC ARROW (S Thai Yang) jumped away awkwardly.

Shortly after the start, ULTIMATE HERO (SS Vanan) was tightened by CLASSIC ARROW which shifted in and OUR TOUCHE (App Z Khairil) which shifted out and as a result, lost its position.

DANE'S ANATOMY (C Goon) had to be steadied shortly after the start to avoid the heels of DAWN PROSPECT (HS Gill).

Racing to the 1000M, OUR TOUCHE had to be steadied to avoid the heels of DANE'S ANATOMY, and shortly thereafter, had to be steadied again to avoid the heels of CLASSIC ARROW.

Post-race veterinary examinations of OUR TOUCHE and DANE'S ANATOMY revealed no obvious abnormality.
