RACE 1 (R528) CLASS 5 - 1100m(str) - WINE MAN HANDICAP

GOLD COAST CAPTAIN which was up 22kgs in body weight since its last run, was checked by the Club Veterinary Surgeon prior to the race and was passed fit to start.

FUMIO (HS Gill) jumped away awkwardly and shifted in.

PISCES GEM (App SU Lim) was slow to begin.

FUMIO laid in racing to the 150M.

RACE 2 (R529) CLASS 5 – 1100m(str) – TIEN AN MUN HANDICAP

UNDERCOVER MISSION (App KC Tham) jumped away awkwardly and shifted in abruptly.

MARCO POLO (App AK Lim) shifted out racing to the 150M, resulting in ARCHAEOLOGY (App Z Khairil) being tightened for room and brushing the running rail and having to check inwards to obtain a clear run.

At the conclusion of an inquiry today, App AK Lim, the rider of MARCO POLO in the presence of acting master, Trainer Nor Azman was found guilty to a charge of careless riding under MRA Rule 44(9)(a)(ii) in that whilst riding MARCO POLO, he allowed his mount to shift out at the 150M, when insufficiently clear of ARCHAEOLOGY, resulting in the gelding having to be checked.

In assessing the penalty, the Stewards took into consideration App AK Lim's disciplinary record and mitigating factors. App AK Lim was suspended from riding in races for a period of two (2) Malaysian race days with effect from Monday, 25th April 2016 and to expire on Sunday, 1st May 2016, both dates inclusive. He was informed of his right of appeal (4.20pm).

The Club Veterinary Surgeon reported that POWER WIND (WK Yan) returned with a cut to its off fore foot and had bled. As such, POWER WIND will be barred from racing for a period of three (3) months under MRA Rule 92(3)(a)&(b) and thereafter, passed a bleeder's test before being declared to race again.

LOVE ME (Y Aify) shifted in and bumped IWA ANTILIA at the 200M.

The Stewards questioned Jockey Y Aify, the rider of LOVE ME and Mr. Evert Van Breukelen, the Trainer of the gelding. After taking initial evidence, the Stewards opened an Inquiry into Jockey Y Aify's ride and adjourned the Inquiry till tomorrow.

LUXURIOUS CHOICE (CK Tan) was slow into stride.

The Stewards questioned Jockey CK Tan, the rider of LUXURIOUS CHOICE as to the gelding's poor performance. His instructions were to get a good jump and try to race mid-field, but after LUXURIOUS CHOICE was slow to begin, he had got back further than expected. He further stated that LUXURIOUS CHOICE failed to respond to his riding and ran a disappointing race.

Post-race veterinary examinations of LUXURIOUS CHOICE, GET THE LOTSKI (WK Yan) and REAL MEAN (J De Souza) revealed no obvious abnormality.

Amendment:

APPLICATION FOR A STAY OF SENTENCE AGAINST THE SIX (6) MONTHS DISQUALIFICATION & RM50,000 FINE FOR TRAINER PRAKHASH PEREIRA CONCERNING POST-RACE "STREET TEASE" WHICH RAN 1ST IN RACE 4 (R1489) ON SATURDAY, 12th DECEMBER 2015, PERAK TURF CLUB DECEMBER MEETING 2015 WHICH RETURNED POSITIVE TO "MORPHINE", A PROHIBITED SUBSTANCE IN TERMS OF MRA RULES.

The Stipendiary Stewards on Sunday, 17th April 2016 heard an application for a stay of sentence from Trainer Prakhash Pereira of his six months' disqualification and RM50,000/- fine.

After hearing submissions from Trainer Prakhash Pereira, the Stipendiary Stewards decided to grant him a stay of sentence for a period of fourteen (14) days, from 17th April 2016 to 1st May 2016, both dates inclusive, in order for him to finalize his business arrangements.

Trainer Prakhash Pereira's application for a stay of sentence on the fine of RM50,000/- was denied. He was advised of his rights of appeal to the Racing Stewards against this decision (11.10am).
